Design
Standards
Basics II

In general, the Standards allow for the removal (with permit) of alterations less than 50 years old. For example, requests to remove plastic siding to expose and fix up underlying original siding are approved. This decision is so accepted that permits are granted by Planning without the Landmark Commission getting involved. If a previous owner added a back room in 1980 and you wanted it torn down, you'd probably get that approval, too.

Alterations older than 50 years are viewed on a case-by-case basis. Let's say a previous owner committed alumicide in 1959. Planning would unquestionably allow the removal of the aluminum and restoration of the original siding.

However, removing *original* elements (e.g., gingerbread, doors, or porch posts) is generally not permitted. Removing rotten original features to replace them with identical or near-identical duplicates is permitted. For example, if the bottom of your porch post is too shot to fix with surgical excision followed by prosthetic epoxy, the Planning Department would approve removal of the rotten portion of the post and replacement with wood of the same dimension.

Permission to *demolish* a structure *less than* 50 years of age does not directly violate the Standards, but gaining such permission needs to be based upon one of three criteria: lack of safety, intent to replace with a more compatible structure, or providing evidence that the current structure has no economic viability. Under most circumstances, demolition of a property that fits with the historical tone of the neighborhood is forbidden.

Permission to demolish a structure *older than* 50 years but not in keeping with most of the neighborhood gets sticky, because the Standards are less specific here. For example, when owners of a 1940s Art Deco house on Broadway in the East End wanted to demolish the structure last year, the issue was decided by a split decision. Had the house been Victorian, chances are the owner would not have been granted a demolition permit. If instead it had been a 1975 ranch, a "yes" vote would have been the likely outcome. Interpretation of the Standards

inevitably requires some subjectivity on the part of commissioners.

Owners of historic buildings deemed by Landmark to be unsafe and beyond repair may be given a demolition permit. Demolition by neglect (wherein the property owner willfully allows the building to fall into disrepair so that it becomes unsafe) currently lies in a gray area.


